96.3 WDVD'S "VISIT FLORIDA TRIP GIVEAWAY" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of radio station WDVD ("Station"), owned and operated by Detroit Radio LLC, 3011 W. Grand Blvd, Suite 800, Detroit, MI 48202, during normal business hours Monday through Friday or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **96.3 WDVD's "VISIT FLORIDA TRIP GIVEAWAY"** Contest (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. This Contest is open only to legal U.S. residents, excluding Florida and New York residents, age twenty-one (21) years or older at the time of entry with a valid Social Security number and who reside in the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, who have not won a prize from the Station in the last 30 days or a prize valued at \$500 or more in the last 180 days, and whose immediate family members or household members have not won a prize from the Station in the last 30 days or a prize valued at \$500 or more in the last 180 days. Void where prohibited by law. The term "immediate family members" includes spouses, parents and step-parents, siblings and step-siblings, and children and stepchildren. The term "household members" refers to people who share the same residence at least three (3) months out of the year. The Contest is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Station's decisions, which are final and binding in all matters related to the Contest. Winning a prize is contingent upon fulfilling all requirements set forth herein.

- 2. **Contest Period.** The Contest will begin at **8:00am ET on March 2, 2020** and will run through **6:10pm ET on March 20, 2020** (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.
- 3. **How to Enter.** To enter:
 - (i) On-Air & Text: Listen to the Station weekdays from 8:00am ET to 8:15 am ET, 1:00pm ET to 1:15pm ET, and 6:00pm ET to 6:15pm ET during the Contest Period. When the Station plays the "cueto-text" sounder, listeners should text the keyword "FLORIDA" to Station at (313) 298-9630. Texter (9) nine to the Station with the correct keyword, as determined by the Station in its sole discretion, will be qualified to win. *Time Delay Between Over-the-Air Analog Signal and Internet Broadcast:* Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished.
- 4. **Winner Selection.** Each weekday of the Contest Period, Station will play one (1) "cue-to-text" sounder during each of the time frames listed above. Texter nine (9) with the correct keyword as announced by the Station will win a Qualifying Prize (as defined below) and be entered to win the Grand Prize (as defined below). The winning entrant will be contacted using the telephone number used to submit the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification will result in disqualification.

Grand Prize Winner Selection. On or about 7:00pm ET on each of the following dates, Friday March 6, 2020, Friday March 13, 2020 and Friday March 20, 2020, Station will select one (1) entry for a Grand Prize in a random drawing from among all valid qualifying entries received by Station during the Contest Period as of the date and time of that drawing. The winning entrants will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification will result in disqualification and forfeiture of the prize.

- Verification of Potential Winner. THE ELIGIBILITY OF ALL POTENTIAL CONTEST WINNERS 5. ARV Four Thousand Two Hundred Twenty Seven Dollars and Twenty Four Cents (\$4,227.24). The actual retail value of the Grand Prize may vary depending on the point of departure, travel itinerary, airfare fluctuations at the time of awarding/booking and/or accommodations. Any difference between the above stated ARV and the actual retail value of the Grand Prize will not be awarded. Winner will be informed of the Actual Retail Value at the time the Grand Prize is redeemed. Winner acknowledges that s/he will be provided a 1099 on the actual retail value. Should the Winner be unable to travel for any reason, Winner immediately forfeits the Grand Prize and at that time, Station may select an alternate Winner in its sole and exclusive discretion and in compliance with these Contest Rules.

SOME JURISDICTIONS DO NOT ALLOW THE LIMITATIONS OR EXCLUSION OF LIABILITY FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE MAY NOT APPLY TO YOU. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of entrant and Station in connection with the Contest, shall be governed by, and construed in accordance with, the laws of the state in which the Station is located, without giving effect to any choice of law or conflict of law rules (whether of the state in which the Station is located or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the state in which the Station is located.
