96.3 WDVD'S "PICK YOUR ENVELOPE" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained by contacting radio station WDVD-FM ("Station"), 3011 W. Grand Blvd, Suite 800, Detroit, MI 48202, during available business hours Monday through Friday, on the Station website www.963wdvd.com, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **96.3 WDVD's "Pick Your Envelope"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. This Contest is open only to legal U.S. residents of the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, excluding Florida and New York residents, age eighteen (18) years or at the time of entry with a valid Social Security number, who have not won a prize from the Station in the last thirty (30) days or a prize valued at \$500 or more in the last six (6) months, and whose immediate family members or household members have not won a prize from the Station in the last thirty (30) or a prize valued at \$500 or more in the last six (6) months Void where prohibited by law. - 3. How to Enter and Win. Listen to the Station each weekdays during the Contest Period, at or about 7:07am ET, 8:07am ET, 11:07am ET and 1:07pm ET (each a "Contest Round"). Each "Contest Round," the Caller will pick one (1) envelope, caller will pick either envelope 9, 6 or 3, to determine which concert tickets will be the prize for that Contest Round. When the Station plays the cue to call, listeners should call the Station at (313) 298-9630. Caller twenty five (25) to the Station, as determined by the Station in its sole discretion, will be the potential winner of the prize for that Contest Round, after providing the Station the winning listener's name and phone number, subject to verification and compliance with these Contest Rules. All entries may be played on the air. *Time Delay Between Over*the-Air Analog Signal and Internet Broadcast: Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished. A winner who returns the affidavit of eligibility and liability/publicity release will be deemed to have accepted the contest prize and thereafter will not be permitted to rescind their acceptance of the prize and/or return the prize.
