96.3 WDVD's "P!NK THREADS GIVEAWAY" CONTEST OFFICIAL RULES

The Station will conduct the **96.3 WDVD's "P!NK Threads Giveaway"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. Entry comments that are removed and/or blocked by Station and/or by Facebook will be deemed not entered in the Contest.

An entrant is providing entry information to the Station and not to Threads.

Station's decisions as to the administration and operation of the Contest and the selection of the potential winners are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within twelve (12) hours of notification or failure to claim the prize within twelve (12) hours of verification as a winner will result in disqualification and forfeiture of the prize.
